Auditor General's report and audit opinion

I certify that I have completed the audit of the Annual Return for the year ended 31 March 2024 of **St Clears Town Council**. My audit has been conducted on behalf of the Auditor General for Wales and in accordance with the requirements of the Public Audit (Wales) Act 2004 (the 2004 Act) and guidance issued by the Auditor General for Wales.

Audit opinion: Qualified

Except for the matters reported below in my Basis for Qualification, on the basis of my audit, in my opinion no matters have come to my attention to give cause for concern that, in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislative and regulatory requirements have not been met;
- is not consistent with the Council's governance arrangements; and
- that the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources.

Basis of Qualification

Accounting Statement

In my opinion, the Accounting Statement does not fairly present the Council's income and expenditure financial position:

- The Council has not provided a properly completed bank reconciliation as at 31 March 2024. The Council have included their creditors and debtors as unrepresented cheques and uncleared payments. Creditors and debtors are not unrepresented cheques nor uncleared payments.
- The Council has not provided a complete explanation for significant variances within the year. The Council has misstated the figure for total other receipts on their analytical review and as such have not provided an explanation for the significant variance.

Annual Governance Statement

In my opinion, the Annual Governance Statement is not consistent with the Council's internal controls and governance arrangements for the year:

- Assertion 1: The Council failed to make up and approve the Accounting Statement by 30 June as required by the Accounts and Audit (Wales) Regulations 2014.
- Assertion 4: The Council did not advertise the audit and make proper arrangements for the public inspection of accounts as required by the Public Audit (Wales) Act 2004 and the Accounts and Audit (Wales) Regulations 2014.

Other matters and recommendations

There are no further matters I wish to draw to the Council’s attention.


